SUPPORT SERVICES ARE PROVIDED TO ASSIST RESIDENTS AS THEY SHAPE AND REACH THEIR GOALS. THIS PROGRAM UTILIZES GROUP RESIDENTIAL HOUSING FUNDS THROUGH A CONTRACT WITH RAMSEY COUNTY. THE FUNDING IS DESIGNED TO SUPPORT WOMEN IN TRANSITION FROM TREATMENT PROGRAMS TO INDEPENDENT LIVING.
