THE WOMEN ARE LIKELY ALL LOW INCOME AND HAVE A DISABLING CONDITION, WITH THE MAJORITY LIKELY EXPERIENCING HOMELESSNESS OR HAVE HAD A HISTORY OF HOUSING INSTABILITY.
