FAMILIES THAT ACHIEVE THIS CAN CHOOSE TO ENROLL IN THE FAMILIES SCATTERED SITE PROGRAM AND CONTINUE TO RECEIVE CASE MANAGEMENT IN THEIR OWN HOMES AS WELL AS PARTICIPATE IN YOUTH ACTIVITIES. BETWEEN THE SITE-BASED AND SCATTERED SITE PROGRAM, 144 PEOPLE WERE SERVED WITH THE VAST MAJORITY BEING CHILDREN. AT EMMA'S PLACE, 87 PERCENT OF FAMILIES MAINTAINED HOUSING FOR 12 MONTHS OR MORE OR EXITED TO SAFE AFFORDABLE HOUSING OF THEIR CHOICE. CASE MANAGEMENT STAFF OFFER HOUSING NAVIGATION SERVICES TO FIND A PRIVATE MARKET RATE RENTAL, AND THEN OFFER HOUSING STABILIZATION SERVICES TO TENANTS AFTER TRANSITIONING FROM BEING UNHOUSED TO HOUSED. IN 2024, 44 INDIVIDUALS WERE SERVED BY THE PROGRAM, WITH 92 PERCENT OF TENANTS SUCCESSFULLY COMPLETING THEIR INITIAL LEASE PERIOD.

IN APRIL OF 2024 ENS MOVED OUR ORGANIZATIONAL HEADQUARTERS AND MAIN ADULT RESIDENCE PROGRAM FROM THE OLD BUILDING IN DOWNTOWN ST. PAUL (EMMA NORTON RESIDENCE) TO THE NEW, TRAUMA-INFORMED DESIGNED BUILDING KNOWN AS RESTORING WATERS IN THE HIGHLAND BRIDGE NEIGHBORHOOD OF ST. PAUL. IN LATE SUMMER WE OPENED THE LIVING ROOM, AN INNOVATIVE MENTAL HEALTH MODEL STAFFED BY PEER SUPPORT SPECIALISTS. THE LIVING ROOM HAS BEEN PROVIDING FREE, DROP-IN MENTAL HEALTH SERVICES SINCE AUGUST 2024, EXPANDING TO SEVEN DAYS A WEEK IN OCTOBER 2024, AND EXPANDING TO TELEHEALTH IN MAY 2025. THIRTY PEOPLE WERE SERVED BY THE LIVING ROOM IN 2024.
