EACH PROVIDES CASE MANAGEMENT AND PEER SUPPORT THAT ALLOW CLIENTS TO ENGAGE IN GOAL PLANNING, REFLECTION, AND CRISIS MANAGEMENT TO EMPOWER WOMEN IN FINDING TRANSFORMATION THROUGH HOUSING. ALL PROGRAMS HAVE SIMILAR ELIGIBILITY CRITERIA WHICH INCLUDES DOCUMENTATION OF HOMELESSNESS, AND DISABILITY.

EMMA NORTON RESIDENCE (ENR) HOUSES SINGLE WOMEN IN EITHER SINGLE OR DOUBLE OCCUPANCY ROOMS, CONTRACTING THROUGH THE STATE OF MINNESOTA FOR HOUSING SUPPORT FUNDS. IN FY 2022 94 CLIENTS WERE SERVED IN EMMA NORTON
